#### Please explain the reasons for your response

We have surveyed our parents and found many differences of opinion so are unable to present a majority voice on this issue. We can confidently say that the majority of parents fully support the 20mph areas around schools and many would like these to be for the whole school day and for them to be extended to a slightly larger area. Whilst parents fully support any initiative which may ensure greater safety for their children, many obstacles were cited. For example parents in Edinburgh and the surrounding Lothians described many unsafe situations that are now occurring due to the city wide 20mph limit, explaining there are many drivers becoming annoyed and frustrated and then endangering other road users and pedestrians. Parents also have concerns about increased emissions whilst driving at 20mph. Many parents explained that they would prefer to see resources spent on compliance with existing speed limits, and were concerned that most drivers would ignore a new 20mph limit.
