I live in Dumbreck, a few hundred yards from the site of a fatal accident. However whenever I walk along Nithsdale Road today, I feel nothing has changed. Many of Glasgow's roads are wide due to the termination of tram services, and this results in traffic exceeding speed limits on a regular occurrence. I work in intensive care and have seen first hand the effects that road traffic accidents can have on individuals and their families.
