1) I have not been able to find any credible evidence to support that the reduction to 20 mph would reduce pollution, in fact because people would and indeed should be driving in a lower gear with increased revs I would have thought that the emissions from the vehicle would be greater rather than less. It is also spending more time in a particular street, (because it's driving slower), spewing emissions as well. As I have said I haven't been able to find any credible studies anywhere saying that a blanket 20 mph will reduce pollution. 2) Following on from this I also haven't seen any scientific evidence or even studies put forward that a blanket reduction in speed to 20 mph will have an effect on accident rates. I would suggest that more visible police to enforce the current limits, especially around schools during the appropriate times would be more beneficial. 2) Whilst there are reasons to have a 20 mph limit in certain areas, schools being a prime example which I applaud, the vast majority of streets in our towns and cities are more than capable of carrying traffic at the current 30 mph limit, this just seems to be an idea that someone has had and decided to run with it rather than trying to gather proper evidence and facts before proceeding.
