#### Please explain the reasons for your response

Imposing more rules will make no difference other than more rules will get broken. This is a pointless exercise. The way to improve safety is through education, not enforcement. Reasonable and thoughtful drivers already reduce their speed to when it is suitable and don't when it is not necessary, so this will simply criminalise those good people who understand how to judge a safe speed. And to those who aren't reasonable and thoughtful, the new limits will continue to be ignored just like the old limits. Bottom line is, there are no benefits to this proposal.

Drivers can be categorised into two groups - people who are competent, considerate, safe drivers, and people who are not.

The first group already drive safely and economically, they know what speed to drive at on any given road and will adjust their driving to conditions. Blanket reductions in speed limits serve only to slow down drivers like this unnecessarily (bearing in mind, where it is safe to do no more than 20mph, they will do 20mph even if the limit is currently more, so this will only affect areas where it is safe to do more but is covered by the blanket). This means more cars on the road for more time, increasing congestion and frustration, which is a very important cause of accidents that we must consider.

The second group of people simply don't care. They ignore 30mph limits and other laws and will continue to ignore 20mph limits in the same way.

This proposal only serves to criminalise people who are not actually doing anything unsafe and serves only to increase frustration amongst motorists.
