Please explain the reasons for your response

Modern vehicles have a much better braking system than the vehicles that were used to test for the original highway code. Stopping distances are much higher, driving test skills are taught to a much higher level. Slowing cars down further is more harmful to the environment as there will be more emissions produced as engines are not designed to run at such low speeds and a lower gear will need to be used to enable full control of the vehicle. If anything speed limits should be increased with the modern braking systems on cars, the introduction of ABS on all vehicles now (including motorbikes)

Safety 'could' be cited as one, but with such a slow speed, many drivers will be so careful to be checking the Speedometer they will not be looking where they are going.

As 20mph is such a low speed, modern cars are not calibrated well even and the accuracy of the speedometer would be in question.

Q4. What do you think would be the main disadvantages, if any, of the proposal?

- 1. Drivers will be looking at their speedometer for the unrealistic speed required. This means they will be distracted from the road ahead.
- 2. Emissions, cars will be running in lower gears at higher revs, thus:
- a. using more petrol
- b. creating more noise in built up areas
- c. if they are not in lower gears they will not be in full control of their vehicles
- 3. A further safety concern is, due to the ridiculously low speed threshold, many drivers will simply overtake the cars adhering to 20mph thus causing more of a hazard in the very build up areas that the Bill is (niavely) intended to reduce the risk of accident through a misplaced understanding of speed being the cause of incidents. INAPPROPRIATE SPEED may be contributed to accidents, NOT Speed itself.
