#### Please explain the reasons for your response

At the moment there is a 30 mile speed limit in the village of Keig with flashing lights of 20mph in the morning, at lunchtime and after school. Unfortunately drivers do not stick to either of these speed limits. Recently we have been out and about in the village with groups of children both walking and doing Bikeability training(high visibility vests worn by teachers and pupils) and have noted drivers driving at much higher speeds despite seeing children. At times we have had to get helpers wearing high visibility vests to wave down the drivers before they reach the groups of children. If there were one limit of 20 mph all the time in front of the school then I think drivers might lower their overall speed.
