Q3. What do you think would be the main advantages, if any, of the proposal?

The proposal offers a relatively less expensive means of applying a blanket reduction in speed in built-up areas, with a consequent reduction in serious accidents involving pedestrians.

Q4. What do you think would be the main disadvantages, if any, of the proposal?

Even on a rural island, people need to attend to business. Traffic is already slowed by cyclists, farm traffic and animals, frequently delaying those attending hospital, catching ferries and commuting. A blanket speed of 20mph will only exacerbate such problems. We dispute the claimed benefit of fuel economy and emissions reduction, since vehicles are not designed to run efficiently at such low speed, necessitating the use of lower gears.

Q5. What other measures do you think would be needed to maximise compliance with the new national 20mph speed limit on restricted roads, for example in relation to advertising signage and police enforcement.

A high proportion of community comments referred to the difficulty of enforcing current legislation with regard to 20mph restrictions. Having consulted with our local Police force, it is clear that enforcement would involve a great deal of their time.
