As is made clear in the consultation document, local authorities already have statutory powers. From our viewpoint as parent representatives of secondary school pupils, the proposal will make no real difference, because 20mph limits are already in force around schools. However, there are more pressing issues which this proposal entirely fails to address, namely traffic congestion and pressure on car-parking at peak times.

Enhanced safety.

The one-size-fits-all nature of the proposal denies any flexibility to accommodate local situations. It also ignores the issues of congestion around schools at peak times which, in our view, are more pressing.
